

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://mp-sealing.com/>, and M&P Sealing Inc and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to M&P Sealing Inc include <https://mp-sealing.com/>, MPS, M&P Sealing Inc and <https://mp-sealing.com/>. The MPS website is a Gasket Manufacturing site. By using the MPS website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, MPS may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number
- Employer

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. MPS may disclose your personal information, without notice, if required to do so by law or in the

Tracking User Behavior

MPS may keep track of the websites and pages our users visit within MPS, in order to determine what MPS services are the most popular. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by MPS. Security of your Personal Information

- SSL Protocol

 - Debug to identify and repair errors that impair existing intended functionality;
 - Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
 - Comply with the California Electronic Communications Privacy Act;
 - Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
